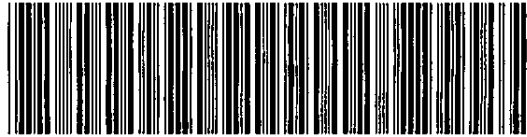

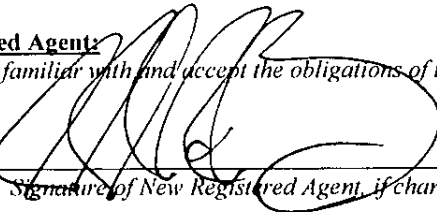

Delete current Article I and replace with the following: The name of the corporation shall be: Church in the Farms Inc.

Delete current Article II and replace with the following: The principle place of business and mailing address of this corporation shall be 13475 West Indiantown Road, Jupiter, FL 33478.

Delete current Article III and replace with the following: The purpose for which the corporation is organized is to establish and disseminate religious beliefs as interpreted by the elder board, affiliated with the Southern Baptist Convention.

Delete current Article IV and replace with the following: Officers of this corporation will be appointed as specified in the Church in the Farms Constitution and Bylaws.

Delete current Article V and replace with the following: Administration of Church Affairs: The affairs of the Corporation shall be managed by the Board of Elders. The Board of Elders shall consist of not less than three members and shall elect from its membership a President, Vice President, Secretary, and Treasurer. If there are only three Elders, then the Board of Elders shall elect from its membership a President, Vice President, and Secretary. The Board of Elders shall hold office pursuant to the provisions of the Church in the Farms Constitution and Bylaws. The Board of Elders shall have such powers, terms, and service and perform such duties as are designated in the Church in the Farms Constitution and Bylaws.

Delete Article VI and replace with the following: The name and position of the Board of Elders to serve until replaced, resigned, or removed as designated in the Constitution and Bylaws shall be: Donald Barnes-President, Max Thompson-Vice President, Eric Brooks-Secretary, Bruce Marshall-Treasurer, and Chris Siggins-Director.

Delete Article VII and replace with the following: The initial Church in the Farms Constitution and Bylaws shall be adopted by the membership. The Church in the Farms Constitution and Bylaws may be altered or amended by the Board of Elders as deemed appropriate by unanimous vote of the Board of Elders unless specifically prohibited in the Constitution and Bylaws.

Delete Article VIII and replace with the following: The Church in the Farms Articles of Incorporation may be altered or amended by the Board of Elders as deemed appropriate by a unanimous vote of the Board of Elders.

Delete Articles IX, X, XI, and XII.

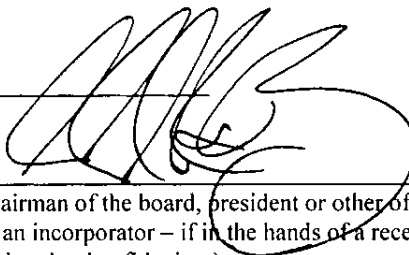
