We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

FIRST

The name of the corporation is: JUST FOR KIDS ACADEMY CORPORATION, DESIRING TO FORM A NON PROFIT CORPORATION, UNDER THE NON PROFIT CORPORATION LAW OF FLORIDA

SECOND

The period of its duration is: INDEFINITELY

THIRD

The purpose of the corporation is: ORGANIZED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL PURPOSES, THAT QUALIFY AS EXEMPT ORGANIZATION UNDER IRS CODE 501 C 3 OR CORRESPONDING SECTION OF ANY FUTURE TAX CODE FOR THE PURPOSE OF A NON PROFIT CHILDCARE CENTER

FOURTH

Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: UPON DISSOLUTION OF THE CORPORATION ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES UNDER 501 3 C OF THE IRS TAX CODE UNDER APPROVAL OF THE BOARD OF DIRECTORS
