## ARTICLES OF INCORPORATION/#3

- [/] THIRD Said corporation/
  charitable, religious, educational and scientific purposes,
  including, for such purposes, the making of distributions to

  organizations under Section 501(c)(3) of the Internal Revenue Code
  (or the corresponding section of any future Federal tax code.)
- FIFTH No part of the net earnings of the corporation/
