## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Ammendment to its Articles of Incorporation.

Article I

The name of the corporation shall be Issues and Options, Inc.

## Article II

#### Article III

The Corporation is organized exclusively for educational and court related services within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding portions of any future United States Internal Revenue Law), including, to the extent permitted by said section 501(c)(3), the dedication of such an organization is to implementing a centralized intake and assessment for batterers' intervention.
