The purpose of this correspondence is to submit our request for reinstatement of our corporation. We submitted our annual business report in May 2001 along with the required \$61.25 filing fee. After a second notification, we submitted it again with another \$61.25 filing fee. We did not receive any further correspondence and I personally checked the Sunbiz.org web site which indicated that we were in good standing. Today I received notice of dissolution of our corporation. I spoke with your office who indicated that our report was rejected because we did not name three directors for our non-profit organization. Apparently we never had three directors as we just renewed the same directors and officers each year and those previous filings were not rejected. We did not receive notification of this error.

At this time, I am submitting the Application for Reinstatement with revisions to the list of officers and directors and of our registered agent. I request that any reinstatement fees be waived and that our overpayment of \$61.25 be refunded to us.
