Butchikas Foundation for Autism, Inc. stating that the foundation has not paid their Annual Report fee for the years 1998 through 2005. The non-profit corporation had changed their address in the later part of the 1997 year. Therefore, we feel the reminder notice from the State of Florida to file their Annual Report was sent to George A.
