

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION SENIOR SOCIETY OF FRIENDS, INC.

FILED 98 JUN 10 AM 9: 24 SECRETARY OF STATE TALLAHASSEE, FLORIDA

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST:

Amend Article IV, paragraph C to read as follows:

No part of the net earnings of the corporation shall inure to the benefits of, or be distributable to its member, trustees, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Articles Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding, any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

SECOND:

Furthermore, all assets of the Senior Society of Friends, Inc. are permanently dedicated to the exempt purpose of section 501(c)(3). Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

THIRD:

The date of adoption of the amendment is June 1, 1998.

FOURTH:

There are no members or members entitled to vote on this amendment. The amendment was Adopted by the Board of Directors.
