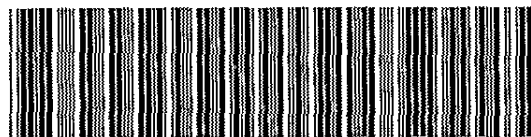

No substantial part of the activities of the organization shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate

of the Internal Revenue Code, or the corresponding section of any future federal tax code
