

The undersigned, with other persons being desirous of amending and restating the Articles of Incorporation of T&T Umbrella Association, Inc., a Florida not-for-profit corporation (f/k/a T&T Water Management Association, Inc.), hereby submits the following. There are no members entitled to vote on these Amended and Restated Articles of Incorporation. These Amended and Restated Articles of Incorporation were adopted by the Board of Directors:

ARTICLE I – NAME

The name of the corporation is:

T&T Umbrella Association, Inc.

The address of the principal office of the corporation shall be 225 Banyan Boulevard, Suite 240, Naples, Florida 34102, and the mailing address of the corporation shall be the same.

ARTICLE II – NATURE OF BUSINESS

The corporation may engage in or transfer in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory, or nation. The purpose for which the corporation is organized is to serve as an umbrella association for certain mixed-use property located in Lee County, Florida.

ARTICLE III MANNER OF ELECTION OF OFFICERS AND DIRECTORS

The Board shall be elected or appointed pursuant to the terms set forth in the corporation's Bylaws and that certain Second Consolidated, Amended and Restated Declaration of Covenants, Conditions, and Restrictions [T&T Umbrella Association], to be recorded in the Public Records of Lee County, Florida, as both may be subsequently amended, supplemented, or restated.


