

# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF



# PARRISH HISTORICAL SOCIETY, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation. The Articles of Incorporation for the Parrish Historical Society, Inc. were filed on May 15, 1997 and assigned document number N97000002790. The Articles of Incorporation were subsequently amended on December 24, 1997.

FIRST: AMEND ARTICLE VIII. BY STRIKING OUT THE WORDS, ENVIRONMENTAL, SCHOLASTIC OR SCIENTIFIC FROM SECTION 2. THE NEW ARTICLE VIII. DISSOLUTION WILL READ AS FOLLOWS:

### ARTICLE VIII. DISSOLUTION

In the event of dissolution of the corporation, the net assets of the corporation shall be applied and distributed as follows:

Section 1. All liabilities and obligations shall be paid, satisfied, and discharged, or adequate provision shall be made thereof.

Section 2. After payment of all liabilities and obligations under Section 1. of this Article VIII., all remaining assets shall be distributed to one or more organizations organized and operated exclusively for charitable and educational purposes as shall at the time qualify as tax exempt under Section 501(c)(3) of the Internal Revenue Code, or any subsequent law of the United States of America.

SECOND: The date of adoption of the amendments was: 2-17-98 at a duly held meeting of the Board of Directors.

THIRD: There are no members entitled to vote on the amendments. The amendments were adopted by the Board of Directors.
