ARTICLE OF AMENDMENT TO NON PROFIT ARTICLES OF INCORPORATION

The undersigned incorporator (s). Pursuant to Chapter 617.1006 Florida Statutes under the Florida Not For Profit Corporation:

ARTICLE I

The name of the this corporation is: HISPANIC CENTER OF CHRISTIAN LOVE, INC.

ARTICLE III

The specific purpose or for which the corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the (3) of the Internal Revenue Code (or meaning of section 501(c) corresponding section of any future Federal tax code.) THE PURPOSE OF CONCILIO EVANGELICO DE AVIBAMIENTO WILL BE TO CHURCHES IN MINISTRY. CONCILIO AFFLIATE OTHER EVANGELICO DE AVIBAMIENTO WILL ALSO HAVE ITS OWN SUBORDINATE CHURCH INSIDE AND OUTSIDE THE USA. NOT LIMITED TO BUILDING OTHER CHURCHES, INSTITUTES AND SCHOOLS, CLINICS, CLOTHING, FOOD, AND REHAB. CENTERS. TO CONDUCT RELIGIOUS SERVICES, ORDAIN MINISTER, BAPTISM AND PREFORM MARRIAGE CEREMONIES.

ARTICLE IV

The manner in which the Director(s) are elected or appointed will be by holding a meeting set fourth by the Officers and Board of Directors of the Corporations, who shall by the majority of vote elect or appoint at such time Directors for such term as provided in accordance to corporate bylaws.

ARTICLE VII

No part of the net earnings of the corporation shall inure to the benefit of, or be distribute to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501© (3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities not permitted to be carried on (a) by a corporation/organization exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of nay future federal tax code) or (b) by a corporation/organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE VIII

Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501 $\mathbb O$ (3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or shall be distributed for a public purpose.
