I. CHARITABLE CORPORATION

* CORPORATION NOT FOR PROFIT formed under the Florida General Corporation Act.

Article 1: Name of Corporation CHRIST GOSPEL CHURCH OF SOUTH FLORIDA, INC.

Article 2: DURATION: Term of existence of the corporation is perpetual unless dissolved according to law.


