Dear Sir or Madam:


We are a not-for-profit corporation that did not file our Uniform Business Report properly last year. Since we are an all-volunteer organization, I believe I have pieced together why we did not receive the 2001 renewal form. The address listed on our old documents indicates the form would have been sent to Naomi Katz (our registered agent) at 5947 Memorial Highway, Tampa, Florida 33615. This is where Ms. Katz's worked for many, many years. (It was the Travel Agency of Tampa.) To make a long story short, Ms. Katz left her position due to some health problems. Then with-in a few months the business relocated to a different address in Palma Ceia and finally the business actually closed for good a few months after that.

Unfortunately since we are all volunteers and our officers change each year, the new secretary/treasurer was not aware we should be receiving a form and since it did not arrive, she also did not know she should be looking for it or requesting it.

The Optimist Club of Town 'N Country has been in existence for just five short years and during that time we have worked hard to make a difference in our community.
