AMENDMENT TO ARTICLES OF INCORPORATION OF THE GLEN ATAGORISM GOLDEN EAGLE HOMEOWNERS ASSOCIATION,

Pursuant to the provisions of Section 617.1006, Florida Statutes, this corporation adopts the following amendment to its articles of incorporation:

FIRST: Amendments adopted:

Article VII shall read as follows:

MEMBERSHIP: Every person or entity whose is a record owner of any lot is entitled to membership and voting rights in the association. Membership is appurtenant to, and inseparable from, ownership of the lot.

Article VIII shall read as follows:
