Sub paragraph ©

Line 10; That portion of the sentence after the word "by" and before "a" remove the words a public accountant at the completion of each fiscal year."

And substitute the words "two (2) elected board members, not elected as officers" add a comma (,) after officers, add a period (.) after the words fiscal year, remove the word (and) then add the words "The Treasurer" before the word shall. Line 9, 10 & 11 will read as follows:
