



ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
URBAN LEAGUE OF PENSACOLA, FLORIDA, INC.

Pursuant to the provisions of Section 617.0120(1)-(6) of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is the URBAN LEAGUE OF PENSACOLA, FLORIDA, INC.
2. The text of each of the amendments is as follows:

AMENDMENT TO ARTICLES OF INCORPORATION  
OF URBAN LEAGUE OF PENSACOLA, FLORIDA, INC.

"Notwithstanding any other provision in these Articles to the contrary:

Said corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, as same may have been subsequently amended.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, i.e., charitable, educational, religious or scientific, or corresponding section of any future Internal Revenue Code, or shall be distributed to the Federal government, or to a state or local government for a public purpose."


3. The amendments were adopted on the 7th day of May, 1999 at a meeting duly called for the purpose of amending the Articles of Incorporation.

4. The amendments were duly approved by the appropriate majority of the membership of the corporation, and the number of votes cast in favor of adopting the Amendments were sufficient for approval, in accordance with the Articles of Incorporation, By-laws, and in accordance with 617.1002-1006, Florida Statutes.
