ARTICLES OF DISSOLUTION OF CHRIST COMMUNITY LUTHERAN SCHOOL, INC. (With Plan of Distribution)

After notice duly given, a meeting of the board of directors of Christ Community Lutheran School, Inc., a Florida not for profit corporation, (the "Corporation") was held on the 21st day of April 2009. To The Hispanic Ministry of Messiah Lutheran Church; and

To Open Arms Ministry of Peace Lutheran Church.
