(the "Association") by its President, for the purpose of complying with the provisions of Section 617.1401 of the Florida Not for Profit Corporation Act, as amended (the "Act") relating to the filing of Articles of Dissolution, does hereby execute the following Articles of Dissolution.

1. Name of the Association is Wyndham Lakes West Community Association, Inc.
2. The Association filed its Articles of Incorporation on July 25, 1997.
3. The Corporation has not commenced to conduct its affairs.
4. The Corporation has no debts that remain unpaid.
5. The Corporation has no assets.
