The name of the corporation shall be Family and Community Resource Support Services, Inc. This corporation is organized pursuant to the FLORIDA Non-Profit Corporation Codes.

ARTICLE II:

ARTICLE III:

The specific purpose (s) for which the corporation is organized is as follows: This corporation is a nonprofit public benefit corporation and no part of any net earnings shall ensure to the benefit of any private member.
