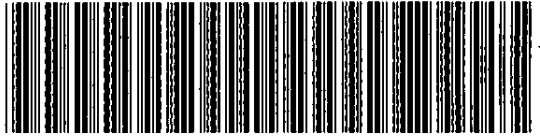

Pursuant to the provisions of section 617.1006, Florida Statutes, this **Florida Not For Profit Corporation** adopts the following amendment (s) to its Articles of Incorporation:

ARTICLE III – PURPOSE being amended:

- To implement Pre-school and After School Academy
- To establish First Baptist Church Medical Center implementing medical services to low to very low community residents while servicing others within Palm Beach County

- ARTICLE IX – ASSETS AND DISSOLUTION, being added:

Upon Dissolution of the organization all assets shall be distributed as per the law deemed for a Florida Not-for-Profit organization. Assets will be distributed to other Not-For-Profit organizations who exist within the meaning of Section 501 © 3. No assets obtained will be for the personal benefit of any Board or Staff Member.

ARTICLE X- NET EARNINGS, being added:

No part of the net earnings of the corporation or organization shall inure to the benefit of, or be distributable to its members, trustees, directors, officers of other private persons, except that the corporation

or organization shall be authorized and empowered. To pay reasonable compensation for services tendered and to make payments and distributions in furtherance of Section 501 © 3 purposes.

ARTICLE XI- POLITICAL ACTIVITY, being added:

No substantial part of the activities of the corporation or organization shall commit the carrying on of propaganda, or otherwise attempting the influence legislation, and the corporation or organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to any candidate for public office.

ARTICLE XII- PROVISIONS, being added:

Notwithstanding any other provision of these articles, the corporation or organization shall not carry on any other activities not permitted to be carried on (A) by a corporation or organization exempt from federal

federal tax code) or (b) by a corporation or organization, contributions to which are deductible under section 170 (c) (2) of the internal revenue code (or Corresponding section of any future federal tax code.
