ARTICLES OF AMENDMENT

98 JUN - 1 PM 3:59

SECRETARY OF STATE TALLAHASSEE, FLORIDA

This document shall serve as an amendment to the Articles of Incorporation for the corporation known as Coral Springs Police Motorsports, Inc. which was incorporated/formed on August 5, 1997.

(1) The original Articles of Incorporation shall be amended by adding language to Section 4 of Article II, entitled "Purpose" and shall read as follows:

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that organization shall be authorized and empowered to reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

(2) The Board of Directors held a vote on the above amendment on April 29, 1998 and May 6, 1998 at which times it passed the amendment by a vote of 6-0. The members of Coral Springs Police Motorsports, Inc. are not entitled to vote on proposed amendments.
