#### ARTICLES OF AMENDMENT

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Amendment:

#### ARTICLE I NAME

The name of the corporation shall be: GO YE MINISTRIES, INCORPORATED.

#### ARTICLE II

#### Principal place of business and mailing address

The principal place of business of this corporation shall be: City of Bartow, State of Florida.

The mailing address of this corporation shall be: 8420 E. Palmer Road, Bartow, Fl., 33830

# ARTICLE III (amended) Purposes

The specific purposes for which the corporation is organized are: The manifold purpose of sharing the LOVE OF GOD with those people, wherever it be asked or allowed to hold meetings, gatherings, fellowship, expressly to tell the GOSPEL of the LORD JESUS CHRIST, by the way of witnessing and create an atmosphere and fellowship by which people in churches, nursing homes, public streets, etc., can witness the ministry of the WORD OF GOD through Gospel Music and Evangelism. Said corporation is organized exclusive for charitable, educational, religious or scientific purposes, withing the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.

#### ARTICLE IV

#### Manner of election of directors

The manner in which the directors are elected or appointed is as follows: Two Corporate Executive Officers, President, Vice President, Treasurer, Recording Secretary and Corresponding Secretary, as stated in the bylaws.

ARTICLE V(Hereby deleted in entirety and replaced by following)

#### ARTICLE V

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to

make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall for be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue code (or corresponding section of an future Federal tax code.)

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state of local government for a public purpose.

However, if name recipient is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)
