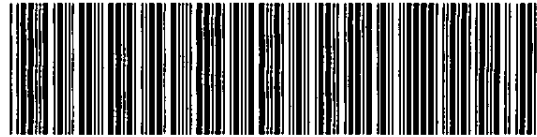

**AMENDMENTS TO THE ARTICLES OF INCORPORATION OF HANUMAN SIDDHI MANDALI AND  
CULTURAL CENTER, INC.  
(A Not for Profit corporation) - 501C3**

Pursuant to the provisions of section 617.1006 Florida Statutes, the undersigned Florida non-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation.

Amendments Adopted:

**ARTICLE I  
NAME**

The name of the corporation shall be Hanuman Siddhi Mandali and Cultural Center, Inc dba Shree Hanuman Mandir. The principal place of business shall be 2563 LB Mc Leod Road, AKA 3119 Lauressa Lane, Orlando, Florida, 32805. The mailing address is HANUMAN SIDDHI MANDALI & CULTURAL CENTER, INC , P.O. Box 555008, Orlando, Florida 32855.

**ARTICLE II  
TERM**

The term of the existence of the Corporation is perpetual.

**ARTICLE III  
PURPOSE**

The purpose for which the Corporation is organized is for worshipping of the Hindu religion and practices, and all other activities necessary to carry out the functions of the Corporation, to engage in any activities and to transact any and all lawful business for which the Corporation may be incorporated under the Florida General Corporation Act and/or permitted under the laws of the United States, as HANUMAN SIDDHI MANDALI AND CULTURAL CENTER, INC dba SHREE HANUMAN MANDIR.

The organization is also organized exclusively for charitable, religious, educational and/or scientific purposes under section 501-C-3 of the Internal Revenue Code.

**ARTICLE IV  
CAPITAL STOCK**

No stocks are issued for non-profit corporation.

**ARTICLE V  
REGISTERED AGENT**

The name of the Registered Agent of HANUMAN SIDDHI MANDALI AND CULTURAL CENT ER INC dba SHREE HANUMAN MANDIR is HARI P. SINGH. The street address of the registered agent is 19606 Oberly Parkway, Orlando, Florida 32833.

## **ARTICLE VI DIRECTORS**

The Board of Directors of the Corporation shall consist of six (6) persons. The names and addresses of the Board members are:

Members of the Board of Directors may also serve on the Board of Executive Officers. Members of the Board of Directors need not be residents of the State of Florida. The Board of Directors are the initial voting members of the Corporation.

## **ARTICLE VII EXECUTIVE OFFICERS**

The Executive Officers of the Corporation must be a resident of the State of Florida. An Executive Officer may hold more than one position. The current officers are as follows:

President	-	Hari P. Singh
Vice-President	-	Gowtam Ramdat
Secretary/Public Relations Officer	-	Sandra Persaud
Treasurer	-	Bibi Zorena Yasin

These Officers will remain in these positions until December 31st, 2010 or until the election and taking of office by their successors.

## **ARTICLE VIII BY-LAWS**

The Board of Directors shall adopt the By-Laws at the first meeting following the adoption of these amendments to the Articles of Incorporation. The proposed By-Laws and any subsequent Amendments shall be approved by a majority vote of the total Board of Directors before becoming the law of the corporation.

## **ARTICLE IX DUTIES**

The duties and/or functions of the Executive Officers shall be defined by the Board of Directors. The duties and/or functions of the priest/s shall be defined by the Board of Directors in consultation with the Spiritual Leader of the corporation. These duties/functions are further explained in the by-laws of the Corporation. The Spiritual Leader is Pt. Chunelall Narine.

## ARTICLE X POWERS

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause thereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501-C-3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170-C-2 of the Internal Revenue code, or corresponding section of any future federal tax code.

## ARTICLE XI ASSETS

Upon the dissolution of the Organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501-C-3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

## ARTICLE XII INCORPORATOR

The corporation hereby reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto.

These Articles of Incorporation supersede all previous Articles of Incorporation and Amendments thereto.

These Articles of Amendments were voted on, and approved unanimously, by the Board of Directors on this 6th day of April, 2009.

All amendments to the Articles of Incorporation shall become legal and binding as of the date of execution which is April 6<sup>th</sup>, 2009
