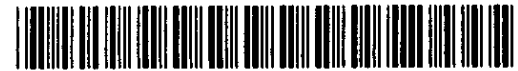


As you can see in the form I have been elected Treasurer of the Towles Court Art Association, Inc., a Florida not for profit corporation.
