**ARTICLES OF AMENDMENT
TO
THE ARTICLE OF INCORPORATION
FOR
NATIONAL AFFORDABLE HOUSING FOUNDATION, INC.**

Pursuant to the provisions of Florida Non-Profit Corporation Act, the undersigned corporation adopts the following Article of Amendment to its Articles of Incorporation which: The corporation has no members. The following amendments to the Articles of Incorporation was adopted by the corporation board of directors on November 24, 1997.

The Articles of Incorporation, are hereby amended so as to read as follows:

No substantial part of the activities of the organization shall be the carrying on or propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

In paragraph II change to read as follows: 'decent low income housing', delete the word 'deceit'.
