# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF RIGHT TO LIFE OF NORTHEAST FLORIDA EDUCATION FUND, INC

FUND, INC., TOPIC

Pursuant to the provisions of section 617.1006, Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

The original Articles of Incorporation filed August 27, 1997, document number N97000005055 and Federal identification number 59 347 0619 are hereby amended as follows:

FIRST: Article III is deleted in its entirety and the following is substituted:

## ARTICLE III

The purposes for which this corporation is organized are exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations under Section 501(C) (3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code)

**SECOND:** The existing Article V is deleted in its entirety and the following is substituted:

## ARTICLE V

This corporation's powers shall be limited to those allowed by 501(C) (3). No part of the net earnings of the corporation shall inure to its members, trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (C) (3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(C) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

THIRD: The existing Article IX is deleted in its entirety and the following is substituted:

## <u>ARTICLE IX</u>

Upon the dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

FOURTH: This amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval. on June 11, 1998.

FIFTH: All other Articles and sections of the Articles Of Incorporation remain as originally filed on August 29, 1998.
