ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of GRATITUDE GUILD FOUNDATION FUND, INC.

NC. SECRETARY OF STATE

Pursuant to the provisions of chapter 617.1006 of the Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment adopted: To amend <u>ARTICLE ONE - NAME AND ADDRESS</u> by striking the first sentence of said Article and in place thereof substituting the following sentence:

The name of this corporation shall be GRATITUDE HOUSE FOUNDATION, INC.

SECOND: Amendment adopted: To amend <u>ARTICLE FOUR - DIRECTORS</u> by striking said Article in its entirety and in place thereof substituting the following:

ARTICLE FOUR - DIRECTORS

The corporation shall be managed by a Board of Directors of not less than eleven (11) members. Their number, qualifications, terms of office, and manner of selection shall be fixed in the by-laws.
