Additionally, we would like to amend Article X - Officers to also change President and Vice President to Chairman and Vice Chairman.

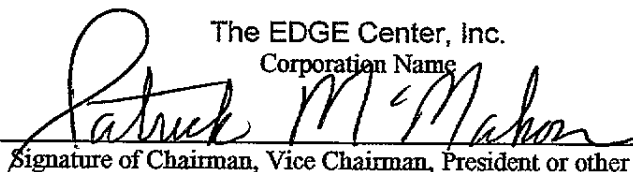
