ARTICLES OF AMENDMENT

ARTICLES OF INCORPORATION

SOURCE Institute, Inc.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: This document amends, in its entirety, the original Articles of Incorporation of the SOURCE Institute, Inc., filed in the State of Florida on 1997 October 10 at 1:26 p.m.. The reasons for this articles of amendment are: (1) to correct and improve readability from the hand written original previously filed, language and grammar; (2) to, more precisely, defined the organization and its intended purposes and (3) to further define its managing, operating and method of dissolving should the occasion arrive.

ARTICLE I NAME: The name of the corporation shall be: SOURCE Institute, Inc.

ARTICLE II PRINCIPAL OFFICE: The principal place of business and mailing address of this corporation shall be: 3170 NW 48th Street, Miami, Florida 33142-3419

exclusively for educational charitable reasons within the meaning of Section 501(c) of the Internal Revenue Code of 1954 and is formed to be a nonprofit corporation to give assistance in offering minority and economically and socially disadvantaged students the opportunity to work, in collaboration with other academic institutions, on and with cutting-edge advanced technologies. SOURCE Institute's student-members develop the skills necessary for doing business with industries and communicating with a diverse work force. SOURCE Institute places the students and faculty in a working and learning environment with leading scientists, researchers, and corporate executives; and also supports on-campus research and development projects. SOURCE Institute members must be registered and in good standing with an Historically Black College or University (HBCU), a Minority Institution (MI), or be a

minority student or faculty member at a non-HBCU/MI institution of higher learning.

No substantial part of the activities of SOURCE *Institute* shall consist of lobbying or propaganda, or otherwise attempting to influence legislation, except as provided in Section 501(h) of the Internal Revenue code of 1986, and SOURCE *Institute* shall not participate in or intervene in (including publishing or distributing statements) any political campaign on behalf of or in opposition to any candidate for public office.

SOURCE *Institute* is not organized for a pecuniary profit. It shall not have any power to issue certificates of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any member, director, or individual. The balance, if any, of all moneys received by SOURCE *Institute* from its operations, after the payment in full of all debts and obligations of SOURCE *Institute*, shall be used and distributed exclusively for educational, technology and scientific research, and charitable purposes.

SOURCE Institute is a student-run company initially established to provide advanced technology research and related services to industry, Government, and academia. SOURCE Institute is designed so that each student could enhance their education and career by receiving industry and governmental agencies training on and off campuses to a schedule that recognizes society's change from a seasonal agricultural economy to a year-round industrial economy. Initial research and development services include virtual environment simulations; statistical analysis; systems integration; software systems architectures, design, development, and test; as well as technical assistance and consultation.

Institute Chief Executive Officer (CEO) is the business and financial executor, general promoter and has ultimate command and control of the corporation. H. (Hank) Harrison Valentine (SSN# 267-60-5294) will serve as the permanent CEO of SOURCE Institute. According, as required by Florida law, the minimum number of three (3) directors must serve as Directors. SOURCE Institute has five (5) Directors (hereafter referred to as the "BOARD". Honorarium of no less than \$6,000 for the CEO, \$2,000 for the Chairperson, and \$600 for all Directors may be paid annually.

Additional Directors can be nominated by any interested academia, industry or government person supporting the objectives and/or goals of SOURCE Institute. Nominees recommended for the SOURCE Institute's BOARD must be approved by the permanent CEO, H.(Hank) Harrison Valentine. The term in office for Directors is consider to be permanent unless a Director wishes to resign or be removed from office by the H. Harrison Valentine Corporation's President. The SOURCE Institute organization is determined by the Board.

ARTICLE VI INCORPORATOR: SOURCE Institute was inspired by and incorporated by the H. Harrison Valentine Corporation (FID# 65-0475976). The name and address of the Incorporator of these Articles of Incorporation, amended, is:

ARTICLE VII Capitalization: The total amount of capital for this corporation is ten thousand dollars (\$10,000).

earnings and assets held within must be used and/or distributed for the furtherance of advancing the minority student-employees interest in professional career developments, i.e., needed for enhancing minority students education and post education career development, such as stipends, scholarships, grants, materials, equipment or such other things that might be used for undergraduate and graduate students, the participating academic institutions, any Historically Black College/University (HBCU), or any Minority Institution (MI) within the United States. If SOURCE *Institute* has to be dissolved, all its assets including the remaining in-hand cash must be distributed, in an appropriate manner, to the benefit of students, participating academic institutions or any Historically Black

College/University (HBCU), any Minority Institution (MI) within the United States.

ARTICLE VIII MEMBERSHIP: SOURCE Institute employs graduate and undergraduate students, as well as utilizing faculty professors as researchers / scientists. A primary objective of SOURCE Institute is to simulate experimental work as measured by increased scientific activity and increased participation in research of both students and faculty. To assist the Board in adopting the SOURCE Institute's bylaws, goals, objectives, and general operating policies, the Board will establish a SOURCE Institute Student Advisory Board (SAB). The SAB is responsible for advising the BOARD, the student officers, and other associates on ways to help in managing the business, regulating the affairs of the corporation that is not inconsistent with law or theses articles of incorporation, and improve SOURCE Institute's moral and doctrine. The SAB membership and structure are defined by the CEO and/or the BOARD. Members are appointed to and removed from the SAB by the CEO, or the BOARD, or by the SAB on "show cause evidence" presented by any SAB member that received a favorable majority vote of the SAB.

The authorized number and qualifications of the members of SOURCE *Institute*, the manner of their admission, the different classes of membership, the property, voting, and the payments for services shall be set forth in the bylaws.

SECOND: The date of adoption of the amendments was: <u>October 13, 1997</u> **THIRD:** The are no members or members entitled to vote on the amendment. The amendments were adopted by the incorporator, who is also CEO, <u>H. Harrison Valentine</u>.
