Pursuant to the provisions of Section 615.1403 of the Florida Not for Profit Corporation Act, PSG Liquidation Corporation, a not-for-profit corporation organized and existing under the laws of the State of Florida adopts the following Article of Dissolution for the purposes of dissolving the Corporation:


1. The name of the Corporation is PSG Liquidation Corporation.
2. Dissolution of the Corporation was authorized by a resolution adopted unanimously by the three (3) members of the Board of Directors of the Corporation on August 1, 1997.
3. The members of this Corporation were not entitled to vote on the dissolution.

These Articles of Dissolution shall be effective as of the filing of these Articles of Dissolution.
