Change Article 2 - purposes to:

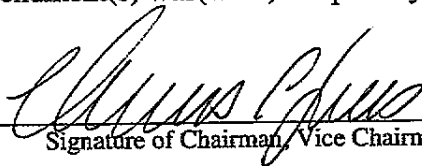
