AMENDMENTS TO THE ARTICLES OF INCORPORATION OF LUCERNE POINTE RECREATION ASSOCIATION, INC.

The Articles of Incorporation of Lucerne Pointe Recreation Association, Inc. is amended as follows (the language added is <u>underlined</u>; the language deleted is <u>struck out</u>):

1. Article III entitled "Purpose" of the Articles of Incorporation of Lucerne Pointe Recreation Association, Inc. is amended as follows:

This corporation is organized for the purpose of providing an entity under the Florida Not-for-Profit Corporation Condominium Act, Florida Statutes Chapter 617, for the operation of recreational facilities located in Palm Beach County, Florida, and for ancillary services and operations. The corporation shall have all of the common law and statutory powers of a not for profit corporation.
