ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION OF THE CHRISTIAN LEGAL AID FOUNDATION, INC.

PURSUANT TO THE PROVISIONS OF SECTION 617.1006, FLORIDA STATUTES, THE UNDERSIGNED FLORIDA NONPROFIT CORPORATION ADOPTS THE FOLLOWING ARTICLES OF AMENDMENT TO ITS ARTICLES OF INCORPORATION.

FIRST: AMENDMENTS ADOPTED: (INDICATE ARTICLE NUMBERS BEING AMENDED, ADDED OR DELETED.)

ARTICLE NUMBER 3 PURPOSES OF CORPORATION IS HEREBY CHARGED TO:

THE PURPOSES FOR WHICH THE CHRISTIAN LEGAL AID FOUNDATION IS ORGANIZED AR EXCLUSIVELY RELIGIOUS, CHARITABLE, SCIENTIFICAL AND EDUCATIONAL WITHIN THE MEANING OF SECTION 500 (c) (3) OF THE INTERNAL REVENUE CODE OF 1986 OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

ARTICLE NUMBER 11 POWERS OF CORPORATION DEFINED IS HEREBY CHANGED TO:

NOTWITHSTANDING ANY OTHER PROVISIONS OF THESE ARTICLES, THIS ORGANIZATION SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE OF 1986 OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

ARTICLE 12 IS ADDED AND SHALL READ:

UPON THE DISSOLUTION OF THE ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE OF 1986, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL, STATE, OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY A COURT OF COMPETENT JURISDICTION OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE ORGANIZATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES.

SECOND: THE DATE OF ADOPTION OF AMENDMENTS WAS FEBRUARY 12, 1998.

THIRD: ADOPTION OF AMENDMENT WAS APPROVED BY THE BOARD OF DIRECTORS, AS THERE ARE NO MEMBERS ENTITLED TO VOTE ON THE AMENDMENT.
