**Community Uplift Progressive Development Corporation**

*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment of its articles of incorporation.*

**FIRST:** Amendment adopted: ARTICLE III Amended to read as follows:

This organization is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the Corporation shall inure to the benefit of any director, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation), and no officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

No substantial part of the activities of the Corporation shall be carry on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Code), or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the organization not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) b an organization whose contributions to which are deductible under the section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

**SPECIALLY:** To accomplish it's objectives, the corporation will:

- a. Raise the economic, educational and social awareness of community members in Volusia County, in various subjects of significance.


- b. Expand on the available opportunities to community members in obtaining housing, health care, and other services consistent with basic human needs.
- c. Develop job opportunities.
- d. Develop programs targeted to the youth to mold them into viable citizens of their community.
- e. Collaborate with local, regional, state and national organizations in the development and revitalizing of the low income community.
- f. Develop tutorial programs to promote substantial improvements in reading, writing and math skills, examination scores, and college entrance exams.
