### a Florida Not-For-Profit Corporation

The undersigned, for the purposes of forming a not-for-profit corporation under Chapter 617 of the Florida Business Corporation Act, does hereby certify as follows:

# Article I Corporate Name

The name of the Corporation is CAPITAL FOUNDATIONS, INC.

### Article II Corporate Address

The address of the principle office and the mailing address of the corporation is:

## Article III Not For Profit

A. The Corporation is a not-for-profit corporation under the laws of the State of Florida.

The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its members, trustees or officers, except to the extent permissible under law.

- B. The Corporation shall be operated pursuant to the applicable provisions of the Internal Revenue Code of 1986, as amended, including, but not limited to, the following special provisions:
- 1. The corporation will distribute its income for each tax year at such time and in such manner so that it will not become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.
- 2. The corporation will not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.
- 3. The corporation will not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.
- 4. The corporation will not make any investments in a manner that would subject it to tax under section 4944 of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.
- 5. The corporation will not make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.

# Article IV Corporate Purposes

The purposes for which the Corporation have been organized are as follows:

A. To receive and administer funds and to operate exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, hereinafter the "Code."

B. To acquire, own, purchase, lease, dispose of and deal with real and personal property and interests, either absolutely or in trust therein and to apply gifts, grants, bequests, and devises and the proceeds thereto in furtherance of the purposes of the Corporation.

C. To do such things and perform such acts to accomplish its purposes as the Board of Directors may determine to be appropriate and as are not forbidden by Section 501(c)(3), or other applicable sections of the Code, with all the power conferred on nonprofit corporations under the laws of the State of Florida.

#### Article V Limitation

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Directors or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

#### Article VI Election of Directors

The initial Board of Directors of the Corporation shall be comprised of three (3) persons.

The Directors shall be elected annually, in accordance with the Bylaws. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall be no less than three (3) directors. The names and addresses of the initial Directors to hold

## Article VIII Nonstock Basis

This Corporation is organized on a nonstock basis. This Corporation shall not issue shares of stock.

The Corporation shall be deemed to commence on the date these Articles of Incorporation are accepted for filing by the Secretary of State, State of Florida.

Article X Duration

The duration of the corporation is perpetual.
