#### ARTICLES OF INCORPORATION

SEURGIANO DE STATE TALLAHASSEE, FLORIDA

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

#### **ARTICLE I-The Corporation**

<u>SECTION 1</u>. The name of the corporation shall be **Philippine American Cultural Federation of South Florida**, Inc, hereinafter called THE FEDERATION.

SECTION 2. The corporate address shall be located at 7601 East Treasure Drive #2001, North Bay Village, FL 33141.

<u>SECTION 3.</u> The Federation's fiscal year starts on July 1 and ends on June 30 of the succeeding year.

SECTION 4. The Federation shall be a nonprofit corporation created to unite the various Filipino-American organizations of South Florida in their quest for cultural development, recognition and enhancement, with the intent of becoming tax-exempt under Section 501(c)(3) of the Internal Revenue Service Code, subject to public auditing and accountability.

4a. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

#### ARTICLE II - Objectives

#### SECTION 1. The immediate objectives of the Federation are:

- <u>1a.</u> To coordinate and organize the activities directed towards the yearly celebration of Philippine Independence Day in South Florida, commencing on the Philippine Centennial Year 1998. This annual activity may be used to raise funds for the purpose of obtaining its long-term goal of setting up a Philippine Cultural Center in South Florida.
- <u>1b</u> To\_unite the various Filipino-American organizations in South Florida and provide integrated community support in promoting their civic, charitable, religious, educational and social activities as a reflection of their Philippine culture and heritage.
- <u>1c</u>. To coordinate and prevent overlapping and conflicts of scheduled community activities by its member organizations.

1d. To act as a Council of Leaders that can advise and help resolve problems among its member organizations.

<u>SECTION 2.</u> The long term goal of the Federation is to set up a Philippine Cultural Center in South Florida that will showcase the Filipino-American cultural heritage.

#### Article 4 - Term of Existence

SECTION 1. The term of existence of the Federation is perpetual unless dissolved by law.

SECTION 2. In the event of dissolution, all money and residual assets remaining after all financial obligations have been cleared shall be turned over to one or more organizations which are themselves exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or local government for exclusive public purpose.

#### ARTICLE V - Amendments and Implementation

<u>SECTION 1</u>. The affairs of the Federation shall be governed by its Constitution and Bylaws which may be reviewed, amended and approved by a majority vote of the official representatives of the member organizations present at a general membership meeting that is especially called for that purpose.

#### ARTICLE IV. Manner of Election

<u>SECTION</u> 1. The Officers and Board of Directors shall be elected by a majority vote from among the official representatives of the member organizations present during a special meeting held for that purpose. The number of Board of Directors shall not be less than five (5) or greater than twenty (20).

#### ARTICLE V. Initial Registered Agent

<u>SECTION 1.</u> The name and address in the State of Florida of this corporation's initial registered agent for service of process are:
