ARTICLES OF INCORPORATION  
OF

KOREAN PRESBYTERIAN CHURCH OF DAYTONA, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation not for profit pursuant to Chapter 617 of the Laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

KOREAN PRESBYTERIAN CHURCH OF DAYTONA, INC.

The address of the principal office of this corporation shall be 4662 S. Clyde Morris Blvd., Port Orange, FL 32119, and the mailing address of the corporation shall be the same.

ARTICLE II

PURPOSES: The purpose for which this corporation is organized is for the exercise and advancement of the religion and faith of the membership. The corporation will focus primarily on promoting and exercising religious faith through gatherings of the membership. In order to carry out these purposes the corporation shall have any powers provided by Florida Statute 617.021 as well as all other express and implied powers of a corporation not for profit provided or allowed by or through the laws of the State of Florida.

ARTICLE III

QUALIFICATIONS OF MEMBERS AND MANNER OF ADMISSION: The members of this Association shall consist of the undersigned subscribers and such other persons as may be from time to time admitted to membership by the Board of Directors of the

corporation in accordance with the provisions of the by-laws of the corporation. There shall be only one class of members.

#### ARTICLE IV

TERM OF EXISTENCE: The term for which the corporation is to exist shall be perpetual, unless sooner dissolved pursuant to provisions of Florida Statute 617, as amended.

#### ARTICLE V

NAMES AND RESIDENCES OF SUBSCRIBERS: The names and residences of the subscribers to these Articles are as follows:

#### ARTICLE VI

OFFICERS AND DIRECTORS: The affairs of this corporation shall be managed by a governing board called the Board of Directors who shall be elected at the regular meeting of the corporation. Vacancies of the Board of Directors may be filled until the next annual meeting, in such manner as provided by the by-laws. The corporation shall have a Board of Directors of three (3) persons initially. The number of directors may be increased or diminished from time to time by the by-laws adopted but shall never be less than three (3). The officers shall be: a President, Vice President, Secretary and Treasurer. They shall be selected by the Board of Directors. The officers and members of the Board shall perform such duties, hold office for such terms, and take office at such times as shall be provided in the by-laws of the corporation.

ARTICLE VII

NAMES OF OFFICERS: The names of the officers who are to serve until the first appointment or election next following the filing of these Articles of Incorporation, pursuant to Florida Statutes Chapter 617, as amended, are as follows:

ARTICLE VIII

NAMES AND ADDRESSES OF DIRECTORS: The first Board of Directors who shall serve until the first meeting of the members or until such time as they shall resign, whichever shall first occur, at which time a meeting shall be called for the purpose of electing a successor or successors pursuant to Florida Statutes, Chapter 617, as amended, are:

ARTICLE IX

BY-LAWS: The by-laws of this corporation may be made, altered or rescinded from time to time in whole or in part only by affirmative vote of the Board of Directors.

#### ARTICLE X

AMENDMENT OF ARTICLES OF INCORPORATION: These Articles of Incorporation may be amended only by The Board of Directors.

#### ARTICLE XI

DIRECTORS: The by-laws shall provide for the voting requirements to elect or remove any of the Directors.

#### ARTICLE XII

Section 1. No officer, director or member shall be personally liable for any debt or other obligation of the corporation, except as provided in these Articles or the corporate by-laws.

Section 2. Each member shall be restricted to one (1) vote except that in all elections for directors each member shall have the right to vote, in person or by proxy, for as many persons as there are directors to be elected or to distribute them on the same principle among as many candidates as he or she shall see fit.

Section 3. The corporation shall not be operated for profit, no dividends shall be paid and no part of the income of the corporation shall be distributed to its members, directors or officers.

Section 4. Any manner or controversy or dispute between members or a member and the corporation shall be settled by arbitration by and in accordance with the rules of the American Arbitration Association and the Statutes of the State of Florida.

Section 5. The members of this corporation shall be subject to all of the terms, conditions, restrictions and covenants

contained in these Articles of Incorporation, and the by-laws of the corporation.
