

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST:

Amendments adopted:

ARTICLE II

The specific purposes for which this corporation is organized, are:

Said corporation is organized as non-profit for charitable, educational and informative purposes, including, the distributions to organizations that qualify as exempt organizations under section 501(c)3 of the Internal Revenue Code.

Proposed purposes included, but not limited, for which this corporation is organized are:

1. Children Services for their Safety, Protection, Prevention of Abduction and/or Abuse. By means of: Children Identification Cards; Counseling Parents and Children as to means of children's Protection. Obtain from FDLE (Florida Dept. of Law Enforcement) the Sexual Predator Directory then contact local Law Enforcement Agencies to assure that the community is made aware when Registered Sexual Predators move into the area and assist in any manner, way or form. Contact schools to assure that the are aware when a Sexual Predator moves in the area, go to school reunions to offer ways to keep protect children. Main Goal: That everyone gets interested and involved in the Safety of Children.
2. Tutoring and other services for children with ADD and ADHD.
3. Assistance for homeless children and their families.
4. Court and Police Record Checks.
5. Immigration Services including, Fingerprints and Photos.
6. U.S. Citizenship Classes and Test.
7. English as a Second Language Classes.
8. Translation and Notarization.
9. Information and Referral Service

10. Income Tax Service
11. Job Referrals and Placement
12. Elderly Programs.

Amendments being added:

ARTICLE VIII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered including that of salaries, and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. Notwithstanding any other provision of these articles, this corporation shall not, carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX


Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

SECOND: The date of adoption of the amendment(s) was: September 26, 1997.

THIRD: There are no members or members entitled to vote on the amendment.
The amendment(s) was adopted by the board of directors.
