ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation is Reachout Community Center of Lake Worth, Inc.

ARTICLE II PRINCIPAL OFFICE

Its principal place of business and mailing address of this corporation will be 1422 Lucerne Ave., Lake Worth, FL 33460.

ARTICLE III PURPOSE(S)

The Corporation exists to initiate and support neighborhood programs which include but are not limited to currently operating community programs whose primary purpose is to help families in their efforts to effect a positive difference in a changing, deteriorating neighborhood. Reachout Community Center, Inc. provides a structure through which government and private organizations can channel their resources into the development of projects that reach families in the Palm Beach Co. area, and specifically, the City of Lake Worth. This Corporation is organized and operated exclusively for charitable purposes and may include involvement in any and all lawful business within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

Section 1. The Board of Directors of the Corporation will consist of the following:

- a. No less than six Directors (up to nine Directors total) divided into three

equal groups, one being elected at each annual meeting of the Board to serve for a regular term of three years.

- b. Two-thirds of the Directors will be members of the sponsoring organization, Lake Worth Church of the Nazarene, Inc.; the other Directors will include, but not be limited to residents, professional and lay leaders of the community.
- c. The President (Ex Officio member).

Section 2. Vacancies on the Board may be filled by the Board at any regular meeting from candidates proposed by the Nominating Committee.

Section 3. The Nominating Committee will present to each Director at least ten (10) days prior to the annual meeting of the Board a written list of proposed candidates to fill the vacancies then existing in the Board and terms expected to expire at the annual meeting. At the annual meetings, the Nominating Committee will place in nomination the names of the candidates to be considered (there being no nominations from the floor) and the nominees will then be voted upon by the Board. A majority of Directors present, a quorum being present, will elect.

Section 4. Two-thirds of the directors will be considered a quorum at all meetings.

Section 5. Participation in activities that conflict with the stated objectives of the Corporation will be cause for removal from the Board of Directors. Removal from the Board of Directors will require a positive vote of 75% of the remaining Directors.
