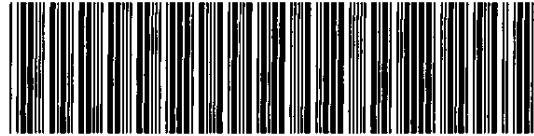



Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

**AMENDMENTS ADOPTED: ARTICLE VII – DISSOLUTION CLAUSE**

The article below is being added to comply with Form 1023 of the Internal Revenue Code.

**ARTICLE VII  
DISSOLUTION CLAUSE**

In the event of any dissolution or other termination of the WHARTON HIGH SCHOOL BAND BOOSTERS, INC., all assets after payment of outstanding debts and other legal obligations shall be paid over to Wharton High School, Tampa, Florida at the address so noted in Article II of this document, or its successor, to be used for the Wharton High School Band, or a successor band; otherwise, for other school music purposes. If Wharton High School, or a successor, does not exist, such assets shall be paid to the Hillsborough County Schools District, Tampa, Florida, to be used for other school music purposes. All assets will be distributed in accordance to the meaning of 501 (c)(3) of the Internal Revenue Code.
