# Articles of Incorporation

Section And the STATE The undersigned incorporator, for the purpose of forming a corporation under the IASSEE, FLORIDA Florida Not for Profit Corporation Act, hereby adopt (s) the following Articles of Incorporation:

#### Article I Name

The name of the corporation shall be:

Victory Harvest Church, Inc.

# Article II Principal Office

The principal place of business and mailing address of this corporation shall be

# Article III Purpose (s)

The purpose for which this corporation is organized is:

- A) Corporation will function as a community church under provision of the 501(C)(3) tax exempt status of the IRS
- B) As a community church and corporation, the corporation will be established for the purpose of ministering to the mental, emotional, moral and spiritual well being of the existing populace through public teaching of Biblical principles, practical outreach projects, and practical moral teaching to the youth and ethnic populace of the community.
- C) As a corporation, attention is given to the written text of The Holy Bible. And as such, the corporation will exist not just to expound on those truths, but to train the community in them and to train existing ethnic populace to evangelize their respective countries with that truth.

# Article IV Manner of Election of Directors

Term of office will be three (3) years.

Original directors will assume position by appointment of the initial registered agent. Thereafter, nominations for directors will be made by the initial registered agent and the existing directors. Said nominations will be voted on for term of office by existing board of directors. The initial registered agent will not hold a vote for directors but will play an active part in discipline and dismissal as stated below:

The initial registered agent will retain the power to remove a director at any time for the following reasons:

\*Inability to fulfill meeting obligations or term obligations \*Non-fulfillment of the by-laws, constitution, or statement of faith of this corporation
