#### ARTICLES TO BE AMENDED

## ARTICLE III PURPOSE (S) ---- TO BE AMENDED AS FOLLOWS:

The purposes for which this organization is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 (C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The scope of the purposes are as follows:

- A) As a community church and corporation, the corporation will be established for the purpose of ministering to the emotional, moral, and spiritual well being of the existing populace through public teaching of Biblical principles, practical outreach projects, and practical moral teaching to the youth and ethnic populace of the community.
- B) As a corporation, attention is given to the written text of the Holy Bible. And as such, the corporation will exist not just to expound on those truths, but to train the community in them and to train existing ethnic populace to evangelize their respective countries by use of the same.
- C) All of these subheadings are and remain governed by the limitation of purposes as stipulated in this article.

## <u>Article IX</u> <u>DISSOLUTION</u>--- TO BE AMENDED AS FOLLOWS:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be

distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

#### ARTICLES TO BE ADDED:

# ARTICLE X LIMITATION OF POWERS—TO BE ADDED AS FOLLOWS:

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
