The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles Of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: **UNITED FOR DESTIN, INC.**

ARTICLE II - PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS

The principle place of business and the mailing address of this corporation shall be: 445 Calhoun Avenue, Destin, Florida 32541..
