- ONE:** The name and address of this principal corporation is New Life Evangelistic Fellowship, Inc., 401 Executive Center Drive #E 203, West Palm Beach, Florida 33401-2923, in Palm Beach County. The corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.
- TWO:** This Corporation is a non-profit religious benefit corporation and is organized under the Non-profit Public Benefit Corporation Law for Religious purposes. To establish structured support services for Evangelistic, Economic Development and other Ministries to support the Outreach Ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the Corporation creed/by-laws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic Development programs, but, shall not be limited to: Homelessness, Health Care, Child Care, Youth at High Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling Employment and other programs to aid those in need.
- THREE:** The duration of this Corporation shall have perpetual existence.

- (a) This Corporation is organized and operated exclusively for Religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provisions of these articles the corporation shall not carry on any other activity not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
