ARTICLES OF INCORPORATION

The undersigned, acting as sole incorporator, does hereby desire to form a not for profit corporation pursuant to the Florida Not For Profit Corporation Act and does hereby adopt the following Articles of Incorporation:

11-3-97

Article I- Name of Corporation

The name of the corporation shall be WILLIE SNEAD'S YOUTH FOOTBALL LEAGUE, INC.

Article II- Term of Existence

The corporation shall commence its corporate existence upon the execution of these Articles of Incorporation and shall exist perpetually.

Article III- General Purpose

The general purpose for which this corporation shall be organized shall be to engage in any lawful act not for pecuniary profit and not specifically prohibited to corporations under the Florida Not For Profit Corporation Act as may be, from time to time amended, or any other laws of the state of Florida. Such purposes include without limitation, charitable, benevolent, eleemosynary, educational, historical, civic, patriotic, political, religious, social, fraternal, literacy, cultural, athletic, scientific, agricultural, horticultural, animal husbandry and professional, commercial, industrial, or trade association purposes.

Article V- Principal Office; Mailing Address


