Articles of Incorporation of Amazon Selva-Peru, Corp.

SECRETANT OF STATE TALLAHASSEE, FLORIDA

A Florida Non-Profit Corporation

Article 1. Name. The name of the Corporation is:

Amazon Selva-Peru, Corp.

<u>Article 2.</u> <u>Duration.</u> The duration of the Corporation is perpetual.

Article 3. Purposes. The purpose of the Corporation is as follows:

The nature of the business and the objects and purposes proposed to be transited, promoted and carried on are to do any and all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, vis:

This is a nonstock, nonprofit corporation. The purpose of the corporation is to engage in any lawful act or activity for which nonprofit corporations may be organized under the General Corporation Law of Florida.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), to wit:

Providing economic and humanitarian aid in the form of food, medical supplies, building materials, etc., to people in impoverished areas of the world.

Article 4. Members. The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and priviliges of members of the Corporation. The Bylaws may provide for Non-voting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and priviliges as are set forth in the Bylaws, but who shall not have the right to vote.
