Article One

Name

The complete legal name of the corporation is ABACO BILLFISH CHALLENGE, INC.

Article Two

Duration

The term of existence of the Corporation is perpetual. The corporate existence will commence on the filing of these articles by the Department of State.

Article Three

Purpose

The corporation is organized in order to engage in the following purposes: to provide a the preservation of Billfish, to benefit the Billfish Foundation, and to assist and coordinate enthusiasts of deep sea fishing, to arrange for fishing tournaments, recreational outings and to coordinate such events, to seek to obtain donations for the Billfish Foundation from such recreational events, to gather and provide information regarding Billfish, Billfish preservation and deep sea fishing and fishing tournaments to the members.

Article Four

Directors



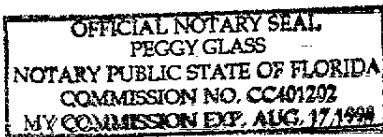

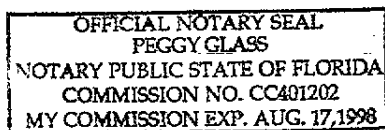
