# **ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

#### **ARTICLE I: NAME**

The name of the corporation is **Hillsboro Beach Women's League, Inc.**

#### **ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation is 1149 Hillsboro Mile PH 9, Hillsboro Beach, FL 33062.

#### **ARTICLE III: PURPOSE**

Philanthropic - raise funds for charity.

#### **ARTICLE IV: QUALIFICATION**

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

## **ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT**

## **ARTICLE X: AMENDMENTS**


The corporation reserves the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
