

**ARTICLES OF AMENDMENT  
OF  
SAWGRASS AT THE STRAND HOMEOWNER'S ASSOCIATION, INC.**

Pursuant to Florida Statute Section 617.1006, the Articles of Incorporation of the above-named Corporation are hereby amended as follows:

A. Article I is amended in its entirety to read as follows:

**ARTICLE II  
PURPOSE AND POWERS**

1. Paragraph 1 of Article II is hereby amended by the deletion of the name "Clipper Cove" in the second line of Paragraph 1 and replacing it with the name "Sawgrass at the Strand".
2. Paragraph 2 of Article II is hereby amended by the deletion of the name "Clipper Cove" in the sixth and eighth lines of Paragraph 2 and replacing them with the name "Sawgrass at the Strand".
3. Subparagraph J of Article II is hereby amended by the deletion of the name "Windstar" in the first line of Subparagraph J and replacing it with the name "Pelican Strand".

**ARTICLE III  
MEMBERSHIP**

1. Subparagraph A of Article III is hereby amended by the deletion of the name "Clipper Cove" in the second line of Subparagraph A and replacing it with the name "Sawgrass at the Strand".


B. The foregoing amendments were adopted on November 8, 1997.



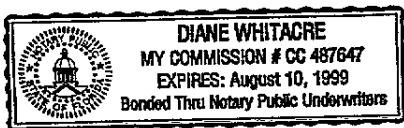
