ARTICLE I

Purpose(s)

To purchase, own, sell, lease, mortgage or pledge any real estate or real properties incident to the purpose of this corporation; to do any and all things incident to the carrying out and the exercising of any or all of the objects aforesaid; to have all the rights and powers enumerated in Section 617.021, and conferred upon corporations not for profit under Chapter 617, Florida Statutes.

No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this Corporation and upon dissolution of this organization all of its assets remaining after payment of all cost and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under 501(c) (30 of the Internal Revenue Code, or the federal government, or to a state or local government for a public purpose, and none of the assets will be distributed to any director, officer or trustee of this Corporation.

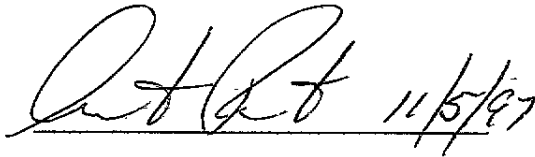
